

## TERMS & CONDITIONS

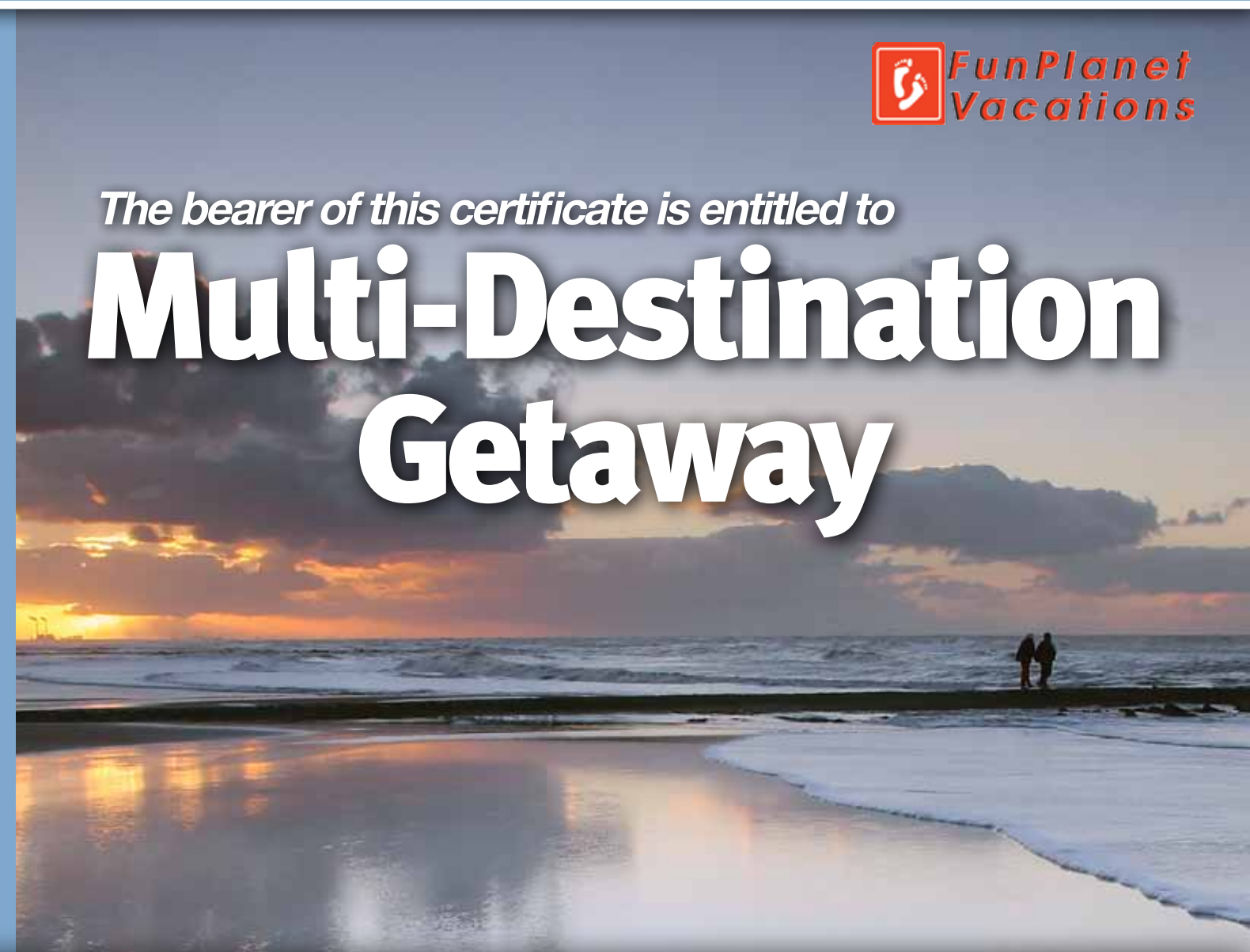
